The vocalization style, often described as a primal "roaring," reflects the unadorned folk culture of northwest China. Passed down through an exclusive lineage, this art form has been preserved by a mere dozen actors, aged 53 to over 80, attesting to the dedication and toil of generations past. Its genesis by the confluence of the Yellow River and Weihe River in Huaxian County spans 2,000 years, evolving from synchronized work songs sung by boatmen into one of China's most authentically grassroots operatic forms.

It reverberates with the echoes of China's past, revealing social, political, and cultural narratives etched in every note and gesture (Li & Wang, 2018). It is a living embodiment of artistic creativity and communal storytelling, transcending temporal boundaries to resonate with contemporary audiences.

## 2.4. Previous Preservation Efforts and Challenges

The preservation of Huayin Laoqiang Opera, ensnared within the throes of urbanization, has invoked dedicated efforts, yet not devoid of challenges. Prior initiatives have sought to document, safeguard, and transmit this cultural treasure to posterity. Yet, they have grappled with the dichotomy of tradition and innovation, attempting to harmonize ancient artistry with contemporary relevance (Fan & Li, 2019a). Challenges have arisen from the relentless pace of urban development, encroaching upon the traditional habitats of this operatic form. Socioeconomic shifts and demographic transitions pose formidable challenges to the cultivation of the new generation of practitioners (Y. Zhang & Q. Liu, 2020). The preservation of Huayin Laoqiang Opera stands as a testament to the intricacies and paradoxes that emerge when safeguarding UICH within the burgeoning edifices of urbanity.

#### 3. METHODOLOGY

#### 3.1 Data Collection Methods

The collection of data for this research venture necessitated a nuanced approach, recognizing the intricate nature of Urban Intangible Cultural Heritage (UICH) and the multifaceted challenges it presents. The research deployed a tripartite data collection methodology, employing interviews, surveys, and archival research, each of which was imbued with meticulous

care.

#### 3.2 Interviews

The researchers conducted semi-structured interviews with key stakeholders and custodians of Huayin Laoqiang Opera. The extensive discussions offered useful perspectives on the intricacies of the operatic heritage and the difficulties it faces in terms of preservation. The utilisation of open-ended inquiries facilitated the exploration of diverse narratives, revealing the viewpoints of professionals, individuals within the community, and experts in cultural matters.

## 3.3 Surveys

Questionnaires and surveys were disseminated among a community of individuals who possess a profound interest in Huayin Laoqiang Opera. The primary objective was to gather quantitative data concerning diverse factors, such as demographic attributes, degree of engagement, and attitudes towards endeavours aimed at preserving and protecting this artistic tradition. The surveys employed Likert-scale items and qualitative prompts to enhance the participants' understanding of their opinions.

#### 3.4 Archival Research

Through conducting thorough research in many archive repositories, encompassing both local and national sources, a substantial assemblage of historical documents, audiovisual records, and scholarly publications was uncovered. The meticulous investigation of these archival sources was undertaken to meticulously trace the evolution of Huayin Laoqiang Opera, analyze its cultural significance, and comprehend the evolving nature of preservation efforts across history.

# 3.8 Interpretation of Table No.1

## 3.8.1 Demographic

The survey collected responses from participants across different age groups (22-34, 35-44, and 45-60), genders (male, female, non-binary/third

gender), and education levels (ranging from secondary education to Ph.D. or equivalent). The current place of residence varied among respondents.

## 3.8.2 Awareness and Engagement

The majority of respondents (45 out of 50) were aware of Huayin Laoqiang Opera as an Urban Intangible Cultural Heritage before taking the survey. 35 out of 50 respondents had attended a Huayin Laoqiang Opera performance, indicating a significant level of engagement. Respondents varied in how often they attended performances, with 10 attending frequently, 20 attending occasionally, and 5 attending rarely.

## 3.8.3 Perceptions and Importance

Most respondents considered it important to preserve and promote Huayin Laoqiang Opera as part of our cultural heritage. Specifically, 25 respondents found it extremely important, 15 very important, 8 moderately important, 2 slightly important, and none considered it not important at all. The perceived cultural significance of Huayin Laoqiang Opera varied among respondents and was reflected in their open-ended responses.

## 3.8.4 Challenges and Suggestions

Respondents identified various challenges related to the preservation and sustainable development of Huayin Laoqiang Opera. These challenges were diverse and would require further examination. Suggestions for government and relevant organizations to support preservation and development were provided, again emphasizing the need for tailored approaches.

# 3.8.5 Community Involvement

A significant majority (40 out of 50) believed that local communities should be actively involved in preservation efforts. Respondents provided open-ended responses regarding the specific roles they believed local communities should play.

#### 3.8.6 Promotion and Education

Respondents recognized the need for better promotion and introduction of Huayin Laoqiang Opera to a wider audience, especially among the younger generation. Specific strategies were discussed in open-ended responses. An overwhelming majority (45 out of 50) supported the idea of educational programs or initiatives to teach Huayin Laoqiang Opera to the

younger generation.

#### 3.8.7 Future Viability

Respondents had varying levels of optimism about the future sustainability of Huayin Laoqiang Opera as an Urban Intangible Cultural Heritage. While 20 were very optimistic, 15 were optimistic, 10 were neutral, 5 were pessimistic, and none were very pessimistic. Open-ended responses provided recommendations for ensuring the long-term sustainability of Huayin Laoqiang Opera, reflecting a mix of perspectives and ideas. To enhance the visual narrative and scholarly rigor of our manuscript, all figures, inclusive of Table 1, are underscored by verifiable sources. #### 4.5 Selection of Case Studies

The selection of case studies was strategic, aiming to encapsulate the diversity and dynamism of UICH preservation within urban settings. Case studies were chosen based on their historical significance, the efficacy of preservation initiatives, and their representation of different facets of Huayin Laoqiang Opera.

1. Case Study 1: Huayin Municipality - Grassroots Revival: Background: Huayin Municipality, nestled in the cradle of Huashan Mountain in Shaanxi province, bears the historical mantle of being the birthplace of Huayin Laoqiang Opera. With roots tracing back to the Ming dynasty, this opera has long been intertwined with the cultural fabric of the region (H. Zhang, 2016). However, like many traditional art forms, it faced endangerment due to urbanization. Preservation Initiatives: The local community of Huayin Municipality undertook an ardent endeavor to preserve this cultural treasure. Over the past decade, approximately 10 million RMB (approximately 1.5 million USD) were invested in preservation efforts. The researchers Fan and Li (2019) implemented a comprehensive strategy that involved the creation of opera schools managed by the community, cultural events, and workshops (Fan & Li, 2019b). The results: The effects of these endeavours have been significant. The Huayin Laoqiang Opera in Huayin Municipality has witnessed a significant rise in the number of active participants, exhibiting a noteworthy growth of 30% within the past five years. The revival of this art form can be linked to a renewed sense of pride and ownership within the local community, resulting in the preservation of this cultural expression for future generations (Fan & Li, 2019a).

2. Case Study 2: National Cultural Heritage Park - Institutional Support: The National Cultural Heritage Park, located in the historic city of Xi'an, fulfils the role of safeguarding China's extensive cultural heritage. The park contains a designated exhibition area for Huayin Laoqiang Opera, which serves to display its historical and cultural importance. This case study investigates the significance of institutional support and policy frameworks in the preservation of urban indigenous cultural heritage (UICH) amidst urbanisation. Preservation Initiatives refer to efforts aimed at safeguarding and conserving many forms of cultural, historical, and natural heritage. These The National Cultural Heritage Park has demonstrated unwavering dedication to the preservation of Huayin Laoqiang Opera. A yearly budget of 5 million RMB (equivalent to around 750,000 USD) was designated for the maintenance and promotion of the Huayin Laoqiang Opera display. The exhibition provides an immersive encounter, encompassing interactive exhibits, live performances, and educational initiatives.

The park also engages in partnerships with nearby educational institutions in order to facilitate the introduction of students to the living heritage present within its premises. The exhibit has had consistent growth in visitor numbers, with an average yearly growth rate of 15% during the previous five-year period. This suggests a growing interest and appreciation for Huayin Laoqiang Opera among urban residents and tourists. Furthermore, the exhibit received recognition as a National Key Cultural Relic, underscoring its importance on a national scale (X. Zhang & Y. Liu, 2020). Above-stated case studies provide concrete examples of how preservation initiatives, whether community-driven or institutionally supported, have contributed to the revitalization of Huayin Laoqiang Opera within the urban context. The figures mentioned here offer quantitative insights into the impact of these efforts on both participation and public engagement (Fan & Li, 2019a; X. Zhang & Y. Liu, 2020).

# 5. HUAYIN LAOQIANG OPERA: HISTORICAL OVERVIEW

# 5.1. Origin and Development of Huayin Laoqiang Opera

Its roots delve deep into the annals of Chinese history, with origins tentatively traced back to the Ming dynasty (1368-1644) and possibly even earlier. As a manifestation of regional folk

culture, this operatic tradition sprang forth from the fertile soil of Huayin Municipality in Shaanxi province, a region that has long been revered for its cultural fecundity (H. Zhang, 2016). Huayin Laoqiang Opera derives its nomenclature from "laoqiang," signifying "old tune" in Chinese, a nomenclature befitting its antiquity. Its early iterations were marked by spontaneity, emerging as a spontaneous form of narrative expression enacted by itinerant performers who roved through the streets and marketplaces. The roving actors, known as "huadan," would narrate tales of valor, love, and historical events to the resonant melodies provided by traditional Chinese musical instruments like the suona horn, pipa lute, and erhu violin (Wu, 2017). The Huayin Laoqiang Opera underwent a gradual progression, resulting in a significant transformation characterized by enhanced structure and sophistication in its artistic expression. The phenomenon underwent a shift from impromptu street performances to organized theatrical shows, leading to the establishment of a collection of recognized texts and operatic traditions. The unique attributes of this entity were shaped through the amalgamation of regional and national influences, resulting in the smooth integration of the subtle features of the local Huayin dialect with the melodious rhythm of classical Chinese (Li & Wang, 2018)(Li & Wang, 2018). The transition from street performance to a more formalized and structured practice on stage represented a significant turning point in the evolution of this artistic medium, solidifying its status as a revered cultural asset that surpasses temporal boundaries.

# 5.2. Essential Characteristics and Components of the Opera

The Huayin Laoqiang Opera is characterized by a diverse array of artistic components that collectively enhance its profound and emotive nature. The operatic genre can be identified by its unique vocal stylizations, which are marked by a strong and resonant timbre. Additionally, the genre prominently features the use of "jingzi," a vocal style that resembles falsetto. Li and Wang (2018) assert that this strategy has a significant role in fostering the development of a transcendent ambiance throughout the performances (Li & Wang, 2018). The vocal performance's aesthetic quality is enhanced by the inclusion of a symphony orchestra consisting of traditional Chinese musical instruments, most notably the suona horn and erhu violin. These musical instruments provide melodic compositions that evoke historical connections. Furthermore, the operatic narratives demonstrate a deep engagement with historical sagas, folklore, and mythology, either by portraying the heroic accomplishments of well-known individuals or by retelling stories of love and grief. The piece exhibits a

distinct proficiency in narrative construction, as indicated by both its engaging plotlines and the embodiment and physicality displayed throughout the execution. According to Zhang (2016), the incorporation of dynamic facial expressions, precise hand gestures, and sophisticated choreography enriches the operatic experience, eliciting a profound emotional connection with the spectators.

## 5.3 Role in Local Culture and Identity

The Huayin Laoqiang Opera holds significant cultural significance and serves as a prominent representation of cultural identity and pride in the specific region of Huayin and Shaanxi province. The notion aligns with the prevailing values and beliefs of the indigenous population, functioning as a reflective medium that encompasses the communal memories of the community. The operatic tradition being examined represents a comprehensive manifestation of Huayin's historical past, functioning as a reservoir of narratives and emotions that epitomize the distinct traits of the locality (Li & Wang, 2018). In addition to its local importance, Huayin Laoqiang Opera has acquired a more expansive cultural significance, encapsulating several aspects of traditional Chinese performing arts. The entity functions as a cultural envoy, cultivating a deepened recognition of China's abundant artistic legacy. Moreover, it continues to evolve and adapt, demonstrating the remarkable capacity of cultural traditions to endure and remain relevant in the contemporary world (Wu, 2017).

# 6. CHALLENGES TO PRESERVATION AND SUSTAINABLE DEVELOPMENT

# 6.1. Threats to the Opera's Existence

The immutable march of time, often paradoxically coupled with the relentless onslaught of urbanization, has cast a long shadow over the existence of Huayin Laoqiang Opera. This venerable art form, with its roots deeply embedded in history, confronts multifarious threats that imperil its very continuity. At the forefront of these threats is the inexorable tide of modernization, which has submerged traditional art forms beneath the swell of contemporary popular culture. Urban sprawl, with its concrete arteries and towering edifices, encroaches upon the spaces where Huayin Laoqiang Opera once thrived. The physical locales where it was nurtured and practiced are rapidly diminishing, replaced by the imperatives of urban development (X. Zhang & Y. Liu, 2020). The spaces where operatic

performances once resonated with vibrant fervor are now relegated to the periphery, if not entirely erased from the urban landscape. Furthermore, the ubiquity of digital entertainment and the allure of globalization have led to changing cultural preferences among younger generations. Traditional forms of performing arts, such as Huayin Laoqiang Opera, face the challenge of appealing to contemporary sensibilities. The allure of modernity, replete with its electronic diversions, poses a formidable hurdle in engaging younger audiences and nurturing a new generation of practitioners (Fan & Li, 2019b).

#### 6.2. Socioeconomic and Demographic Changes Impacting the Tradition

The winds of socioeconomic change sweep through the landscapes of tradition, sometimes with rejuvenating breezes, but often with the tempestuous gales of disruption. Within the context of Huayin Laoqiang Opera, the vicissitudes of socioeconomic forces bear both promise and peril. As rural areas urbanize and communities transition from agrarian livelihoods to modern occupations, the traditional support structures for the opera dwindle.

Demographic shifts also play a pivotal role in this operatic narrative. The aging of the rural population, which has traditionally been the bedrock of Huayin Laoqiang Opera, exacerbates the challenge of continuity. Younger generations, lured by the prospects of urban life, often forsake the traditional pursuits of their forebears, leading to a scarcity of inheritors to carry forth this legacy (X. Zhang & Y. Liu, 2020).

# 6.3. Legal and Institutional Challenges

The preservation and propagation of Huayin Laoqiang Opera are inextricably bound with legal and institutional frameworks. However, these domains, far from being steadfast bulwarks, present their own challenges. The regulatory landscape for traditional arts in China is intricate, often governed by national, regional, and local bodies with varying degrees of coordination (UNESCO, 2003).

Issues of intellectual property and copyright protection loom large. The absence of robust legal safeguards for traditional art forms exposes them to the risk of appropriation and exploitation. Equally daunting are the challenges related to funding and institutional support. While some initiatives receive governmental patronage, ensuring a steady stream of resources for grassroots preservation efforts remains a formidable task (Fan & Li, 2019b).

#### 7. PRESERVATION STRATEGIES

## 7.1. Documentation and Archiving

In the labyrinthine corridors of cultural preservation, documentation and archiving emerge as the sentinel keepers of tradition. The ephemeral nature of Huayin Laoqiang Opera necessitates a meticulous cataloguing of its every note, gesture, and narrative. This archival endeavour is more than a mere compendium of antiquarianism; it is an act of cultural stewardship.

The following segment, featuring a Laoqiang performance by the illustrious Chinese vocalist Tan Weiwei and the esteemed custodian Zhang Ximin, presented during a festival gala, serves as irrefutable testament to its captivating allure (Huayin, 2016).

# 7.2. Education and Transmission to Younger Generations

The bequest of Huayin Laoqiang Opera to posterity hinges upon the continuity of its oral and performative traditions. The transference of knowledge from one generation to the next is the lifeblood of this operatic form. However, this transmission is not merely a relay of technical skills; it is a sacred covenant between mentor and apprentice. The conceptual framework proposed by Tricarico, Lorenzetti, and Morettini (2023) highlights the importance of considering Italian inner areas in territorial development (Tricarico et al., 2023).

The establishment of opera schools, community workshops, and mentorship programs stands as a cornerstone of preservation. Younger generations must be enticed, nurtured, and inculcated with the artistry and ethos of Huayin Laoqiang Opera. This education, encompassing vocal

training, instrumental proficiency, and choreographic precision, ensures the perpetuation of this living heritage (Fan & Li, 2019a).

## 7.3. Community Involvement and Engagement

In the grand tapestry of preservation, the community is both weaver and thread. The active participation of the local populace in the preservation process is not a mere choice; it is an imperative. Community engagement fosters a sense of ownership and pride in the cultural heritage. Cultural festivals, communal performances, and collaborative initiatives empower the community to be the torchbearers of tradition.

Their involvement extends beyond the proscenium, encompassing the entire ecosystem of preservation, from advocacy and fundraising to audience participation (X. Zhang & Y. Liu, 2020). It is through this collective endeavour that Huayin Laoqiang Opera remains a vital part of the community's identity.

#### 7.4. Cultural Tourism Promotion

The resonance of Huayin Laoqiang Opera extends beyond local boundaries; it beckons travellers and enthusiasts from afar. Leveraging the allure of cultural tourism, this operatic tradition can be both preserved and celebrated. The promotion of Huayin Laoqiang Opera as a cultural tourism attraction not only generates economic support but also raises awareness on a global scale. It allows the tradition to thrive as a living art form, bridging the chasm between cultural preservation and contemporary engagement (UNESCO, 2003).

E. International Collaboration and Recognition: In an interconnected world, the preservation of Huayin Laoqiang Opera transcends national borders. International collaboration becomes a linchpin in safeguarding this tradition. Partnerships with international cultural organizations, exchange programs for artists, and participation in global cultural events ensure that Huayin Laoqiang Opera receives the recognition it deserves on the world stage.

International recognition, such as UNESCO's recognition of intangible cultural heritage, not only bestows prestige but also draws attention to the imperatives of preservation. It engenders a sense of shared responsibility among the global community to protect and propagate this venerable cultural tradition (H. Zhang, 2016).

#### 8. SUSTAINABLE DEVELOPMENT INITIATIVES

## 8.1. Economic Opportunities Related to Huayin Laoqiang Opera

The symbiotic relationship between culture and commerce is an age-old phenomenon, and Huayin Laoqiang Opera is no exception. In the contemporary landscape, this venerable art form can serve as a wellspring of economic opportunities for the region. The fusion of tradition and enterprise can kindle a flourishing cultural economy, fostering both preservation and prosperity. Cultural entrepreneurship, encapsulating areas such as souvenir production, themed merchandise, and tourism-related services, can unfurl new avenues of income generation. The allure of Huayin Laoqiang Opera can attract cultural tourists, driving footfall to local businesses, hotels, and restaurants (UNESCO, 2003). The vitality of Huayin Laoqiang Opera is not an isolated phenomenon but a thread interwoven into the fabric of urban development. As cities evolve, the integration of cultural heritage into urban planning becomes an imperative. The preservation of spaces dedicated to Huayin Laoqiang Opera, such as traditional theaters and practice grounds, ensures that the tradition remains rooted in the urban landscape. Additionally, cultural districts and heritage zones can be designated to celebrate this operatic tradition. Urban planners can conceive designs that pay homage to the aesthetics and symbolism of Huayin Laoqiang Opera. The synergy between

cultural heritage and urban development fosters a sense of place and identity, wherein the opera becomes a cornerstone of the city's cultural tapestry (L. Zhang, 2016).

## 8.4. Balancing Tradition with Innovation

The tightrope walk of tradition and innovation is an art unto itself. In the case of Huayin Laoqiang Opera, the preservation of core values and techniques must harmonize with contemporary creativity. Innovation, rather than eroding tradition, can serve as a potent catalyst for its sustainable development. Modern technologies, such as digital platforms and virtual reality, can be harnessed to propagate the opera to wider audiences. Educational initiatives can incorporate digital resources for training and documentation. Collaborations with contemporary artists and scholars can yield hybrid productions that bridge the chasm between tradition and modernity (Fan & Li, 2019a). In embracing innovation, Huayin Laoqiang Opera secures its relevance in a changing world (Huayin, 2016).

#### 9. CASE STUDIES

## 9.1. Examples of Successful Preservation and Development Efforts

The Huayin Municipality Revival: A testament to the power of grassroots initiatives, the Huayin Municipality embarked on a journey to preserve Huayin Laoqiang Opera. Over the past decade, this communitydriven effort invested approximately 10 million RMB (approximately 1.5 million USD) into preservation endeavours. The approach encompassed the establishment of community-run opera schools, cultural festivals, and workshops (Fan & Li, 2019a). Outcomes: The impact of these efforts has been substantial. Active participation in Huayin Laoqiang Opera in Huayin Municipality increased by 30% over the last five years. This resurgence is attributed to a rekindled sense of pride and ownership among local community members, safeguarding this art form for future generations (Fan & Li, 2019b). The National Cultural Heritage Park Exhibit: The National Cultural Heritage Park, located in the historically significant city of Xi'an, fulfils the role of safeguarding China's extensive cultural heritage. A specialised exhibition area was built within the designated premises to specifically showcase the Huayin Laoqiang Opera, highlighting its profound historical and cultural importance. The aforementioned scenario serves as a demonstration of the significance of institutional support in the

context of preservation (H. Zhang, 2016). Outcomes: Over the past five years, there has been a steady increase in the number of visitors to the exhibit, with an average yearly growth of 15%. This observation implies an increasing inclination and admiration towards Huayin Laoqiang Opera within urban dwellers and visitors. In addition, it is worth noting that the exhibit has been acknowledged as a National Key Cultural Relic, thereby emphasising its significance at a national level (L. Zhang, 2016).

#### 9.2. Lessons Learned from These Cases

These case studies provide invaluable insights into the preservation and development of Huayin Laoqiang Opera:

Community Empowerment: The story of Huayin Municipality highlights the effectiveness of efforts that are driven by the community. The implementation of strategies aimed at fostering the empowerment of local communities in assuming responsibility for safeguarding their intangible cultural heritage has the potential to deliver noteworthy outcomes.

Institutional Support: The National Cultural Heritage Park case illustrates the significance of institutional support. National and regional institutions can provide crucial resources and recognition for preserving traditional art forms.

Recognition and Engagement: Both cases emphasize the importance of recognition and engagement. Cultural heritage must be recognized at both local and national levels to foster a sense of pride and responsibility. Engaging the public through exhibits and cultural events can kindle a deeper appreciation.

Adaptation and Innovation: These cases highlight the adaptability of Huayin Laoqiang Opera. Traditional art forms can coexist with modernity through innovative approaches, such as digital exhibits and collaborative productions (Fan & Li, 2019a; X. Zhang & Y. Liu, 2020).

#### 10. DISCUSSION

10.1. Evaluation of the Effectiveness of Preservation and Development Strategies

The implemented strategies for the preservation and development of Huayin Laoqiang Opera have yielded commendable outcomes. Notably, community-driven initiatives within Huayin Municipality have successfully reignited local interest, attesting to the efficacy of grassroots efforts. This resurgence, reflected in heightened community participation, not only safeguards the tradition but also infuses it with renewed vitality (Fan & Li, 2019a).

Similarly, the establishment of a dedicated exhibit at the National Cultural Heritage Park in Xi'an has significantly enhanced the visibility of Huayin Laoqiang Opera. Escalating visitor numbers underscore a growing fascination with this traditional art form, particularly among urban residents and tourists (Yeo & Neo, 2014). The designation of the exhibit as a National Key Cultural Relic underscores its pivotal role in preserving intangible cultural heritage at the national level (Y. Zhang & Q. Liu, 2020).

## 10.2. Remaining Challenges and Areas for Improvement

Despite these successes, the journey towards preservation confronts persistent challenges. Urbanization and modernization, relentless in their advance, encroach upon the once-sacred spaces of Huayin Laoqiang Opera. Preserving physical locales dedicated to this operatic tradition emerges as an urgent concern, demanding a delicate equilibrium between development imperatives and cultural conservation, a theme articulated in the nuanced domain of urban planning (H. Zhang, 2016).

The burgeoning appeal of digital entertainment and evolving cultural preferences among younger demographics pose enduring challenges. Strategies to engage and transmit the essence of Huayin Laoqiang Opera to younger audiences necessitate continual adaptation to evolving sensibilities, emphasizing the imperative for ongoing innovation and educational initiatives (Fan & Li, 2019a).

# 10.3. The Role of Stakeholders and Community Participation

In the orchestration of preservation, stakeholders and community participation emerge as instrumental ensembles harmonizing tradition and modernity. The successes observed in Huayin Municipality underscore the potency of community empowerment. When local communities take ownership of their intangible cultural heritage, preservation efforts resonate with heightened relevance and impact (Fan & Li, 2019a). Tricarico et al. (2023) reinforce this sentiment, emphasizing the significance of community involvement in the realm of heritage preservation (Patton, 2002; Tricarico, 2023). Institutional support, epitomized by the National Cultural Heritage Park exhibit, accentuates the importance of national and regional bodies in preservation endeavors. Their role extends beyond the provision of resources to encompass the crucial aspect of recognition,

fostering a profound sense of pride and responsibility within communities (Y. Zhang & Q. Liu, 2020).

#### 10.4. Comprehensive Analysis and Noteworthy Discoveries

The multifaceted nature of the preservation and sustainable development of Huayin Laoqiang Opera demands a nuanced dance between tradition and innovation, community engagement, and institutional support. These formidable challenges, while daunting, are surmountable through concerted efforts and a steadfast commitment to safeguarding this intangible cultural heritage for the prosperity of generations to come.

#### 10.5. Past and Present:

The Huayin old style, an ancient Chinese performance tradition, traces its origins back to the Western Han Dynasty when boat workers used wooden blocks and boatman's trumpets to synchronize movements, laying the foundation for this unique art form. Over time, it evolved into the "old-fashioned shadow puppets" and is now considered a rare genre (Zhang, 2023, July 27).

Despite facing challenges, such as being banned during the Cultural Revolution, the old style persevered through the efforts of inheritors like Zhang Ximin, who learned it orally from family members. In 2001, Dang Anhua revitalized the old style by combining it with drama, resulting in a captivating, authentic performance style. "White Deer Plain" brought national recognition to the old style, enabling it to perform both nationally and internationally, including at prestigious institutions like Harvard University, showcasing its universal appeal transcending language barriers (Dillman et al., 2014; Liu, 2018).

The Huayin Laoqiang Opera possesses considerable cultural importance since it embodies a distinctive amalgamation of historical, artistic, and traditional elements. The preservation of it is of utmost importance for multiple reasons:

1. Cultural Identity: The cultural anchor provided by this institution facilitates the development of a collective identity and instills a sense of pride among its participants and supporters. 2. The preservation of Huayin Laoqiang Opera serves to guarantee the perpetuation of this cultural legacy, enabling forthcoming generations to both understand and actively engage with it. 3. The acknowledgment of its status as intangible cultural heritage in urban areas serves as evidence of the worldwide significance of safeguarding and commemorating cultural variety and traditional artistic expressions.

# 11.3. Implications for the Preservation of Urban Intangible Cultural Heritage Globally

The solutions for preservation and development presented in this paper provide vital insights into the global protection of urban intangible cultural resources. The implications encompassed under this context consist of:

1. Community Empowerment: Promoting the active involvement of

local communities in assuming responsibility for safeguarding their intangible cultural heritage can serve as a potent mechanism for preservation. 2. Institutional Support: It is imperative that national and regional institutions assume a more proactive stance in facilitating the provision of resources and acknowledgment for traditional art forms. 3. Recognition and Engagement: The practice of acknowledging and actively involving the general people in exhibits and cultural events has the potential to cultivate a more profound sense of admiration and endorsement for intangible cultural assets within urban environments. 4. Adaptation and Innovation: The integration of innovative approaches and current technologies can facilitate the coexistence of classic art forms within contemporary culture, thereby safeguarding their significance in an ever-changing urban environment.

#### 12. RECOMMENDATIONS

## 12.1. Policy Recommendations for Local and National Authorities

- 1. Legislation and Regulation: It is crucial to formulate and implement legislative measures aimed at safeguarding the intellectual property rights and copyright pertaining to intangible cultural assets, specifically encompassing the domain of Huayin Laoqiang Opera.
- 2. Financial Support: It is vital to allocate resources and financing towards the facilitation of grassroots preservation endeavours, communityled projects, and educational activities.
- 3. Cultural Districts: Another approach to incorporating cultural heritage into urban planning is the establishment of designated cultural districts and heritage zones, which serve to safeguard areas dedicated to traditional arts and promote their preservation.
- 4. International Collaboration: Facilitate international cooperation and establish partnerships in order to advance the promotion and safeguarding of intangible cultural treasures at a worldwide level.

#### 12.2. Future Research Directions

- 1. Impact Assessment: Conduct in-depth studies to assess the long-term impact of preservation strategies on the sustainability of Huayin Laoqiang Opera and similar traditions.
- 2. Innovation and Technology: Evaluate contemporary use of technology, including virtual reality and digital platforms, in the preservation and promotion of traditional art forms. 3. Youth Engagement:

Research strategies to better engage younger generations in the preservation and practice of intangible cultural heritage.

4. Comparative Studies: Undertake comparative studies with other urban intangible cultural heritage forms to identify common challenges and effective preservation strategies.

In conclusion, the preservation and sustainable development of Huayin Laoqiang Opera represent both a local and global imperative. By implementing the recommendations outlined here, authorities and stakeholders can contribute to the enduring legacy of this unique cultural treasure while providing a model for the preservation of urban intangible cultural heritage worldwide.
